STATEMENT OF UNDERSTANDING

The following information is important for the safety and protection of your child. Please read the information, sign the form and return to the Y Staff at the Playground of choice. A copy will be kept for record.

- I understand that the Program hours are Monday through Friday, from 10am until 2pm. Rain days, and before and after those times, children will be unattended.
- I understand that my child will be allowed to leave the Playground Program at any time throughout the duration of the program. Children are not required to stay, nor are staff obligated to keep children at the park.
- If a child has not completed Kindergarten, a parent/guardian is to remain at the park for the duration of the stay.
- I understand that should a person arrive to pick up my child who appears to be under the influence of drugs or alcohol, for the child's safety, staff may have no recourse but to contact the police. Please do not put staff in a position where they have to make this judgment call.
- I understand that the Y is mandated by state law to report any suspected cases of child abuse or neglect to the appropriate authorities for investigation.
- I understand that Y staff and volunteers are not allowed to babysit or transport children at any time outside the Y program. Immediate disciplinary action will be taken by the Y toward staff and volunteers if a violation is discovered.
- I understand that children should not receive excessive gifts (e.g., TV, video games, jewelry) from Y staff or volunteers, and that I should report this to a supervisor if they do.
- I understand that my child will be encouraged to return home prior to unfavorable weather. In sudden occurrences, taking cover under the pavilion will be the best response.

- The Playground Program will be cancelled and communicated via Facebook, YMCA website and Rained Out, as well as any City of Easton, or West Ward Community Initiative Facebook page.
- I understand that the Y may use my child's photograph in any official publicity pieces. Publicity pieces include but are not limited to news releases, social media, publications and web use.

I understand that I can help ensure my child's safety by taking an active interest in his or her Y experience. I, too, will monitor volunteer and staff interactions with my child and ask my child specific questions about program activities and volunteer or staff relationships with my child.
